This action was based on a love of the land and a deep faith that the people in our community will increase their support for our work. The agenda relies on partnerships and strong relationships to be successful. Our belief in a healthy, thriving environment is unwavering, and we are in it for perpetuity. We will be fearless in pursuit of lasting solutions for our region's environmental challenges.

For the Land Trust, 2016 was a watershed year. We turned a corner from a series of five-year strategic plans to thinking and acting on a large scale, across

an entire generation. Amidst this planning process, we also managed to conserve approximately 3,500 acres, including a vast swath of forestland in the Klickitat Canyon, wetland and upland forest habitat along Willapa Bay, and lowland foraging habitat for migrating sandhill cranes in Washington.

Our approach to conservation is evolving in real time, and we're more optimistic, ambitious, and committed than ever. I invite you to join us in this commitment, to forever protect the Northwest's greatest places. 3

2016 PROJECT HIGHLIGHTS



WILLAPA BAY. SEAL SLOUGH Pacific County, WA

The Land Trust conserved 374 acres on Willapa Bay at Seal Slough in December 2016. The site consists of tidal wetlands, sloughs, freshwater creeks, and riparian areas, and contains one mile of Willapa Bay frontage, 15 miles of streams, 70 acres of salt marsh, and mature conifer forest.

CRANES' LANDING Clark County, WA

In March 2016, Columbia Land Trust obtained 541 acres of lowlands from the Port of Vancouver. This property will be managed to provide foraging and overwintering habitat for sandhill cranes, which are endangered in Washington.

KLICKITAT CANYON Klickitat County, WA

In December 2016, the Land Trust conserved 2,400 acres near Mount Adams on the east side of the Cascade Mountains in Washington. This conservation project will protect ponderosa pine forest and steep canyon habitats, including more than three miles of the Klickitat Wild and Scenic River important to fish and other wildlife.

MILL CREEK RIDGE, PHASE IV Wasco County, OR

This property's pristine Oregon white oak woodlands and native prairie were acquired by the Land Trust in February 2016. The wildflowers and bunch grasses on these 115 acres bloom profusely in spring and support a host of native pollinators, migratory and resident birds, and other important wildlife.




