LAND CONSERVATION: COLUMBIA LAND TRUST CONSERVES THE MOST IMPORTANT AND THREATENED LAND IN THE LOWER COLUMBIA RIVER REGION, USING ALL THE TOOLS OF PRIVATE, VOLUNTARY LAND CONSERVATION. THE LAND TRUST WORKS EXCLUSIVELY WITH WILLING LANDOWNERS TO FIND WAYS TO CONSERVE, FOREVER, THE SCENIC AND NATURAL VALUES OF LAND AND WATER. LANDOWNERS DONATE OR SELL A CONSERVATION INTEREST IN THEIR LAND, SUCH AS DEVELOPMENT RIGHTS OR FULL OWNERSHIP, TO COLUMBIA LAND TRUST.
