THE LAND TRUST FINDS COMMON GROUND WITH LANDOWNERS AND COMMUNITY STAKEHOLDERS TO PERMANENTLY CONSERVE THE SCENIC AND INTRINSIC VALUES OF LAND AND WATER. IN 2020, THE LAND TRUST CONSERVED 7,050 ACRES ACROSS ITS SERVICE AREA, WHICH EXTENDS ALONG THE COLUMBIA FROM THE DALLES, OREGON TO THE PACIFIC OCEAN. THIS INLCUDED 4,842 ACRES ALONG THE KICKITAT RIVER AND 1,288 ACRES IN THE WASHOUGAL RIVER WATERSHED.
