LAND CONSERVATION: COLUMBIA LAND TRUST CONSERVES AND CARES FOR THE LANDS, WATERS, AND WILDLIFE OF THE LOWER COLUMBIA RIVER REGION THROUGH SOUND SCIENCE AND STRONG RELATIONSHIPS. THE LAND TRUST FINDS COMMON GROUND WITH LANDOWNERS AND COMMUNITY STAKEHOLDERS TO PERMANENTLY CONSERVE THE SCENIC AND INTRINSIC VALUES OF LAND AND WATER. IN 2024, THE LAND TRUST CONSERVED 448 ACRES ACROSS ITS SERVICE AREA, WHICH EXTENDS ALONG THE COLUMBIA FROM THE DALLES, OREGON TO THE PACIFIC OCEAN. THIS INCLUDED OVER 107.4 ACRES OF FORESTLAND IN WASHINGTON STATE.

PUBLIC OUTREACH: THE LAND TRUST'S OUTREACH AND ENGAGEMENT EFFORTS SUPPORT CONSERVATION IN PRIORITY AREAS BY HIGHLIGHTING SUCCESSFUL PROJECTS, PROMOTING ENVIRONMENTAL STEWARDSHIP, AND CONNECTING PEOPLE TO NATURE. THESE EFFORTS INCLUDE GUIDED TOURS, VOLUNTEER EVENTS, EDUCATIONAL PUBLICATIONS, AND COMMUNITY GATHERINGS ALL DESIGNED TO DEEPEN PUBLIC UNDERSTANDING AND SUPPORT FOR CONSERVATION. IT IS THE RESPONSIBILITY OF THE STEWARDSHIP PROGRAM TO PROTECT CONSERVATION VALUES AND TO BE A GOOD NEIGHBOR AND COMMUNITY MEMBER FOR ALL COLUMBIA LAND TRUST PROPERTIES THROUGH SCIENCE-BASED MANAGEMENT. THE LAND TRUST EVALUATES EACH PROPERTY FOR ITS CONSERVATION VALUE, THE THREATS TO THESE VALUES, AND FOR OPPORTUNITIES TO ENHANCE CONSERVATION THROUGH RESPONSIBLE MANAGEMENT.
